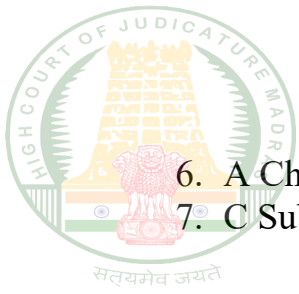

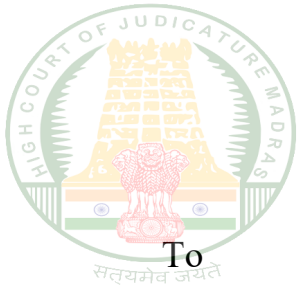
Order
