ORDER

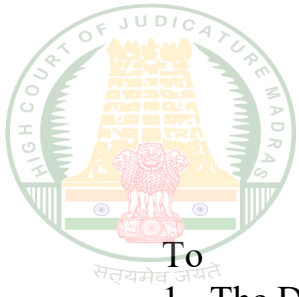
When the matter is taken up for hearing, learned counsel appearing for the petitioner submitted that the matter has become infructuous.
