This Habeas Corpus Petition has been filed seeking directions to the respondents to produce the petitioner's husband Mr.Balasubramaniam, S/o.Ayyavu, aged about 51 years before this Court and set him at liberty.

2 Learned Additional Public Prosecutor, filing the status report, would submit that the petitioner is wife of the detenue and the detenue voluntarily abandoned his family and went to Kasi, Nepal and the second respondent had secured him from one Monastery situated at Dindigul District. Hence there is no illegal detention as reported by the petitioner.

3 The second respondent produced the detenue before this Court and when we enquired him, he informed that he has not been illegally detained by anyone and he only voluntarily left the home.
