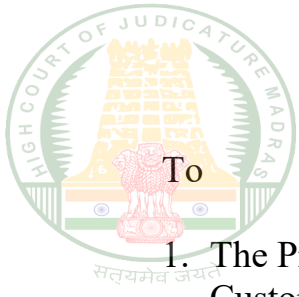
2. The learned counsel for the petitioner submitted that during pendency of the petition, the respondent passed impugned order on 21.07.2025.
