3. Considering the submission made by the learned counsel for the petitioner, this petition is ordered. Accordingly, W.P.No.18050 of 2023 is restored.

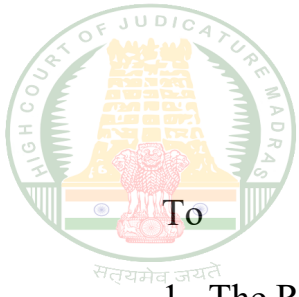
