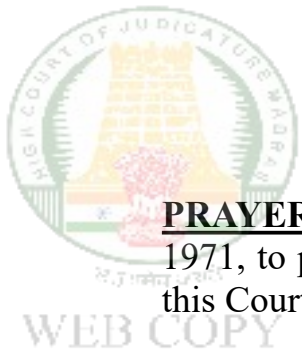

ORDER

When the Contempt Petition is taken up for hearing, the learned counsel for the petitioner submits that the Writ Appeal preferred by the respondent / University vide W.A.No.865 of 2026 was dismissed by the Hon'ble Division Bench of this Court on 08.04.2026.

2. The learned counsel for the petitioner submits that the Hon'ble Division Bench of this Court while dismissing the said Writ Appeal, had granted the respondents two months time to comply with the order of this Court, dated 17.03.2025 in W.P.No.35440 of 2019.

3. Since, it is now brought to the notice of this Court that the Hon'ble Division Bench having dismissed the Writ Appeal preferred against the order of this Court passed in the Writ Petition, the respondents are bound to comply with the order within the time enlarged by the Hon'ble Division Bench.
