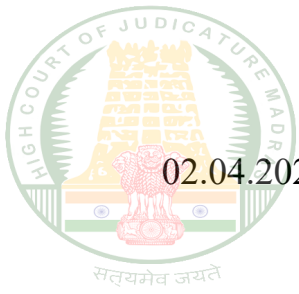

3. In view thereof, the Contempt Petition is closed with liberty to the petitioner to work out her remedy in the manner known to law. No costs.

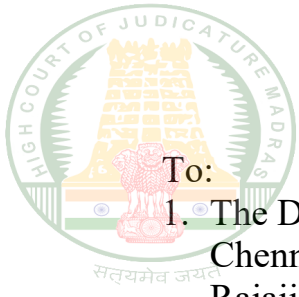
