2. When the matter came up for hearing on 21.11.2025, this Court passed the following order:-

This original petition has been filed under Section 11(5) of the Arbitration and Conciliation Act, 1996 seeking for appointment of an Arbitrator to adjudicate the disputes between the petitioner and the respondents in terms of Article 10 of the arbitration loan agreement dated 01.08.2023.

2. The trigger notice under Section 21 of the Arbitration and Conciliation Act has been issued on 09.06.2025.
