ORDER

The petitioner has filed this petition seeking a direction to the Principal Subordinate Judge, Ponneri, to dispose of the suit in OS No.137 of 2017, as expeditiously as possible.

The trial Court has not made substantial progress in the matter and has been granting repeated adjournments without restriction. months from the date of receipt of copy of this order. Both parties are directed to cooperate for expeditious disposal of the trial proceedings.
