PRAYER

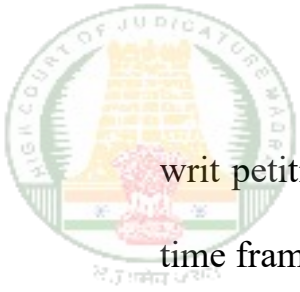

The petitioner claims that he has been in possession of the property morefully described in the prayer to this writ petition for a long number of years and therefore, he claims that he is entitled for free house site patta in his name. The petitioner has, therefore, given a representation on 03.10.2025 to the respondents, seeking for issuance of free house site patta in his name, since the said representation has not been considered till date, this writ petition has been filed.

3. Mr. D.Ravichander, learned Special Government Pleader accepts notice on behalf of the respondents.

4. No prejudice would be caused to the respondents if the petitioner's representation as stated supra is considered on merits and in accordance with law after hearing the objections of any other third party whom the third respondent deems it fit to enquire within a time frame to be fixed by this Court.

5. This Court is not expressing any opinion on the merits of the petitioner's representation dated 03.10.2025.

For the foregoing reasons, this Court directs the third respondent to pass final orders on merits and in accordance with law on the petitioner's representation dated 03.10.2025, seeking for issuance of free house sit patta in his name for the property morefully described in the prayer to this writ petition within a period of twelve weeks from the date of receipt of a copy of this order after hearing the objections of any other third party whom the third respondent deems it fit to enquire.

7. Accordingly, this writ petition is disposed of. No Costs.
