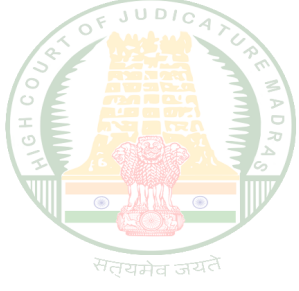
Ms.Selvirajesh, learned counsel for the petitioner makes an endorsement in the Court bundle to the effect that this contempt petition is not pressed.
