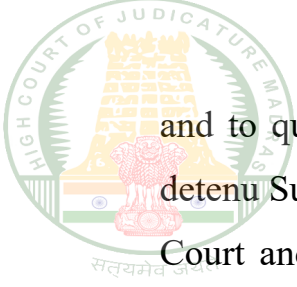

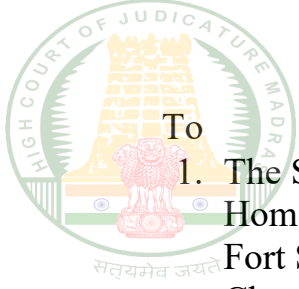
(Order of the Court was made by Dr.Anita Sumanth J.)

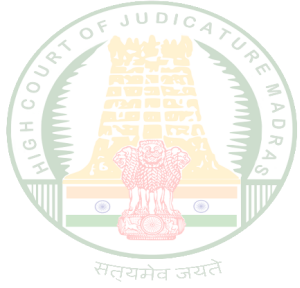
