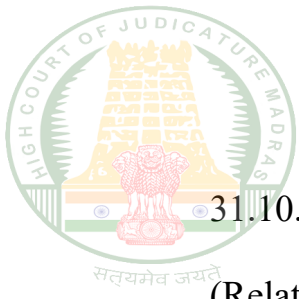

(Relating to Banks and Financial Institutions), City Civil Court, Chennai.

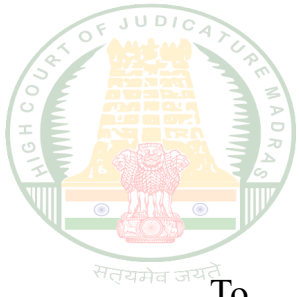
