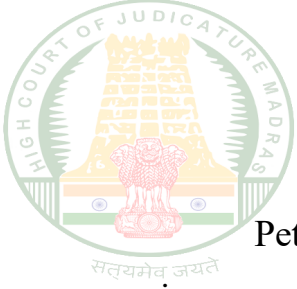

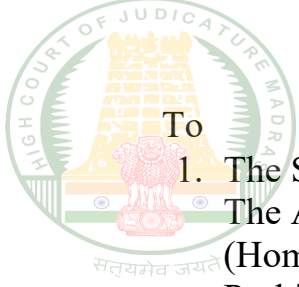
Order
