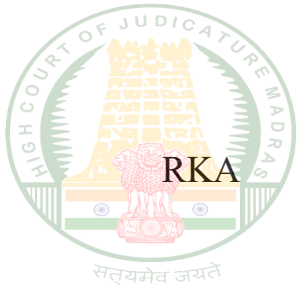
This Civil Miscellaneous petition has been filed seeking to condone the
