This petition has been filed to review the order dated 07.11.2025, passed by this Court in W.P.No.18918 of 2025, thereby this Court dismissed the writ petition.

2.The petitioner herein filed the above writ petition to quash the order issued by the second respondent therein dated 19.06.2024 and to direct the respondents therein to provide pension to the petitioner as approved by the Board of Directors of the respondent Bank and further approved by the Ministry of Finance, Government of India, New Delhi.
