5.No prejudice would be caused to the respondents if the petitioner's representation as stated supra, is considered, on merits and in accordance with law, after hearing the objections of the neighbouring land owners or any other third party, if any, whom the second respondent deems it fit to enquire, within a time frame to be fixed by this Court.

For the foregoing reasons, this writ petition is disposed of by directing the third respondent to pass final orders, on merits and in accordance with law on the petitioner's representation dated 02.12.2025 seeking for issuance of patta in her name for the property morefully described in the prayer to this writ petition, after hearing the objections of the neighbouring land owners or any other third party, if any, whom the third respondent deems it fit to enquire, within a period of 12 weeks from the date of receipt of a copy of this order. No costs.
