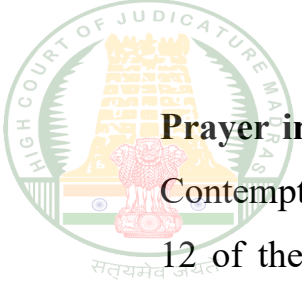

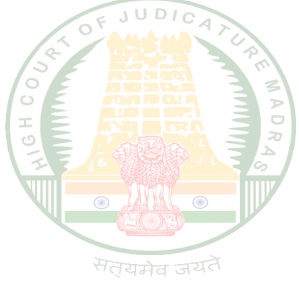
COMMON ORDER
