PRAYER

Writ Petition filed under Article 226 of the Constitution of India, seeking for
issuance of a Writ of Certiorarified Mandamus, calling for the entire records



pertaining to the illegal, arbitrary and unlawful appointment of the 4th respondent as the Nominated Member (Differently-Abled category) of Thiruninravur Municipality, Tiruvallur District, made by the 2nd respondent in Na.Ka. No.405/ 2021/F1 dated 25.11.2025 and quash the same as being contrary to G.O. Ms. No.119, Municipal Administration and water Supply Department, dated 26.06.2025 and violative of Rule 153-A of the Tamil Nadu Urban Local Bodies Rules, 2023, since the 4th respondent neither possesses any social service credentials nor satisfies the mandatory eligibility criteria prescribed for nomination under the Differently -Abled category and consequently directing the 2nd respondent to consider the petitioner's application dated 29.07.2025 strictly in accordance with G.O. Ms. No.119 dated 26.06.2025 read with Rule 153-A and to appoint the petitioner as the Nominated Member (Differently-Abled Category) of Thiruninravur Municipality, based on disability status, residency, merit, social service credentials and all other statutory eligibility norms.
