The 5th and 6th respondents are directed to conduct the Joint Inspection and file a report to the 3rd respondent, within a period of two weeks, from the date of receipt of a copy of this order." has been complied with in letter and spirit and the Compliance Report/Counter Affidavit filed by the 5th and 6th Respondents may kindly be placed before the Hon'ble High Court and and therefore it is humbly prayed that the Contempt petition filed by the petitioner may kindly be got dismissed, as the proposed link road does not pass through or affect the land in Survey No.13/7 belonging to the petitioner, and as the writ petition has been filed with ulterior motive, consequent to the lawful removal of encroachment made by the petitioner's family on the Panchayat open well and its restoration for public use, and not on any genuine or legal grievance relating to the road work.
