ORDER

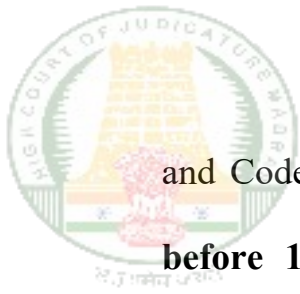
This Civil Miscellaneous Petition has been filed to condone the delay of 648 days in filing the above appeal.
