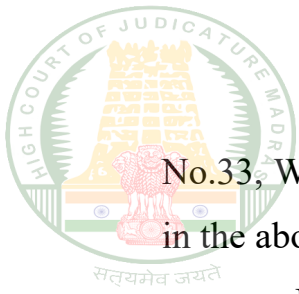

3. Registry is directed to carry out necessary amendment in the cause title and post the main writ petition on 13.07.2026.

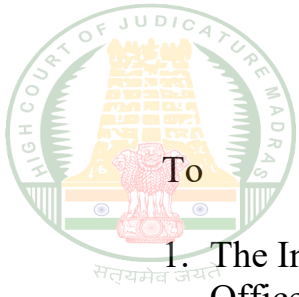
