ORDER

This Civil Revision Petition is filed seeking speedy disposal of O.S.No.334 of 2023 on the file of the District Munsif, Poonamallee.

2. The petitioner herein/plaintiff filed the above said suit for bare injunction against the respondents/defendants. A perusal of the adjudication papers filed in the typed set of papers would indicate that the pleadings of the parties were already completed and the suit was posted for trial as early as in June 2024. Further perusal of the adjudication papers would indicate that PW1 was already examined in chief and the suit was posted for cross examination of PW1, as last chance on 13.08.2025. Thereafter, there is no substantial progress in the suit and the same is still in the stage of PW1 cross.
