ORDER

This petition has been filed to modify the condition 9(b) imposed on the petitioners in Crl.O.P.No.33521 of 2025 dated 05.12.2025.

2. The learned counsel appearing for the petitioners submitted that the petitioners had already obtained bail orders in Crl.O.P.Nos.31708 and 31747 of 2025, dated 24.11.2025 and have been complying with the conditions imposed therein before the Sub-Inspector of Police, Katpadi Police Station, Vellore District, in connection with the Crime No.357 of 2025. In respect of the present Crime No.41 of 2025, the petitioners were granted bail in Crl.O.P.No.33521 of 2025 dated 05.12.2025. Therefore, he prayed that the petitioners may be permitted to appear before the Katpadi Police Station at Vellore, for the purpose of complying with the conditions imposed under the said order dated 05.12.2025.

3. The learned Government Advocate (Criminal side) appearing for the respondent submitted that, the petitioners are complying with the condition regularly imposed by this Court.
