PRAYER: Criminal Original Petition is filed under Section 528 of Bharatiya Nagarik Suraksha Sanhita/Section 482 Cr.P.C, to direct the Principal District Judge, Kallakurichi to accept the surrender of the petitioner on merits in connection with the case in Crime No.731 of 2025 on the file of the Inspector of Police, Kallakurichi Police Station, Villupuram District dated 23.11.2025 on the same date of his surrender.

ORDER

The present Criminal Original Petition has been filed seeking a direction to the Principal District Judge, Kallakurichi, to accept the surrender of the petitioner and consequently consider his bail petition on the same day, on merits, in connection with Crime No.731 of 2025 on the file of the second respondent Police.

2. In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to the Principal District Judge, Kallakurichi, to consider the petitioner's bail application, preferably on the same day of his surrender, in connection with Crime No.731 of 2025 on the file of the second respondent Police and to pass appropriate orders in accordance with law, after affording due opportunity to the victims under Section 15-A of the SC/ST (PoA) Act, 1989. The petitioner shall surrender before the jurisdictional Court within a period of fifteen days from the date of receipt of a copy of this order.
