ORDER

Heard.

1. This Transfer Civil Miscellaneous Petition has been filed by the defendant in O.S.No.196 of 2025 under Section 24 of the Code of Civil Procedure, seeking withdrawal of the said suit from the file of the II Additional District Munsif Court, Salem and transfer of the same to the I Additional District Munsif Court, Salem.
2. This Court notes that both the Courts, namely, the II Additional District Munsif Court, Salem and the I Additional District Munsif Court, Salem, are Courts functioning within the same civil jurisdiction and District judiciary.
3. In such circumstances, an efficacious statutory remedy is available to the petitioner to invoke Section 24 CPC before the Principal District Judge, who exercises administrative control over both the said Courts, for appropriate

orders, if so advised.

4. In the absence of any exceptional circumstance made out for this Court to exercise its discretionary jurisdiction under Section 24 CPC in the first instance, this Transfer Civil Miscellaneous Petition is not entertained.

5. Accordingly, TR.C.M.P. No.9 of 2026 is dismissed. Consequently, C.M.P. No.191 of 2026 is closed. There shall be no order as to costs.
