been conducted and encroachment found, notice has been issued under Section 7 of the Tamil Nadu Land Encroachment Act, 1905, to the private respondents on 31.12.2025 and copy of the same is placed for our perusal.

Since the respondents have already initiated action against the private respondents on the allegation of encroachment, this petition need not be kept pending and is disposed of with a direction that the enquiry shall be concluded as early as possible, preferably within three months from the date of receipt of a copy of this order.

There shall be no order as to costs.
