No prejudice will be caused to the official respondents, if the aforesaid representation of the petitioner is considered on merits and in accordance with law, after hearing the objections, if any, from the fifth respondent as well as any other party, whom, the third respondent deems it fit to enquire. Accordingly, this Writ Petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the third respondent is directed to issue notice to the fifth respondent and also to any other party, whom, the third respondent deems it fit to enquire.

b) After receiving objections, if any, and after considering the same, the third respondent shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
