PRAYERThe Writ Petition is filed under Article 226 of the Constitution of India for the issuance of a Writ of Mandamus directing the respondents to pay interest @6 percentage for the belated payment of terminal benefits such as Gratuity, Commutation of pension amount and Provident Fund to the petitioner for the period from 31.05.2024 (Date of Retirement) till the date of settlement.

**ORDER**

WEB COPY This Writ Petition has been filed, to direct the respondents to pay interest @ 6% for the belated payment of Gratuity, Commutation of Pension and Provident Fund amount to the petitioner.

2. It is the case of the petitioner that the petitioner, who had joined the service of the respondent Corporation, had retired from service on 31.05.2024, however, the terminal benefits have been settled only on 02.12.2025. Therefore, the petitioner claimed 6% interest on the belated payment of terminal benefits and he has also made a representation on 13.12.2025 to pay interest for the belated payment of terminal benefits which has not been evoked any response so far. Hence, the petitioner is before this Court.

3. Heard the learned counsels appearing on either side and perused the materials available on record.

4. In view of the limited request made by the petitioner with regard to interest on the belated payment of terminal benefits, this Court directs the respondents to pay interest @ 6% for the belated payment of terminal benefits from the date of retirement till the date of actual disbursal of terminal benefits



of the petitioner, within a period of six weeks from the date of receipt of a copy of this order taking into account the bank rate of interest on deposits.
