When the matter was taken up for hearing, the learned Government Advocate (Criminal Side) appearing for the respondents 1 to 3 submitted that there is no complaint pending against the petitioner on the file of the respondents 1 to 3 and the respondents have not summoned the petitioner. In such circumstances, there is no question of harassment, whereas, the petitioner has given a complaint against the fourth respondent before the respondents and in the said complaint, enquiry is being conducted by the second respondent in C.No.G2/2744/14433/2025 and during such enquiry, the respondent police will not harass the petitioner.

3. Recording the aforesaid submission made by the learned Government Advocate (Criminal Side), this Criminal Original petition stands closed.
