In such circumstances, there is no question of harassment, whereas, the petitioner has given a complaint against the third respondent before the first respondent and in the said complaint, enquiry is being conducted by the second respondent in C.No.3/Ins/HP/Genrl/2025, dated 10.12.2025 and during such enquiry, the respondent police will not harass the petitioner.

3. Recording the aforesaid submission made by the learned Government Advocate (Criminal Side), this Criminal Original Petition stands closed.
