2. Heard Ms.N.Jayabharathi, learned counsel for the petitioner.

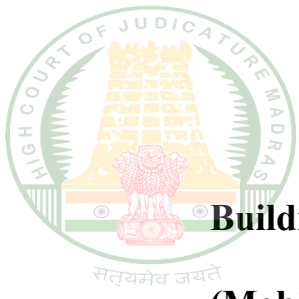
3. In spite of service of notice to the respondents, they have neither appeared in person nor represented through their counsel.
