PRAYER in CMP No. 4188 of 2019 :

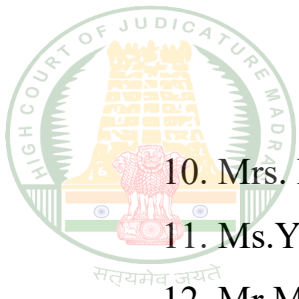
