3. In such being the case, no further order is required in this writ petition as the request of the petitioner has been considered already and the gate has been removed.

4 In view of the same, this Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petitions are closed. It is made clear that if any private dispute is pending, this order will no way affect the rights of the parties to adjudicate the dispute before the Civil Court.
