ORDER

2. Heard the learned counsel for the parties. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

When the matter was taken up for hearing, the learned Special Government Pleader appearing on behalf of respondents 1 to 3 submitted that the second respondent had issued proceedings recommending issuance of patta in favour of the petitioner and that the same is now pending before the third respondent.
