## **ORDER**

In view of the same, without expressing any opinion on the merits of the matter, this Court directs the 3<sup>rd</sup> respondent to consider and pass orders on the representation of the petitioner dated 21.11.2025 on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order.

6. With the above direction, this Writ Petition is disposed of.  
There shall be no order as to costs.
