ORDER

[Order of the Court was made by DR.G.JAYACHANDRAN, J.]

It is the case of the petitioner that he is in occupation of the subject land, which is a natham land, and he has put up a residential house thereon and has obtained electricity service connection to the said house and he has also been regularly paying property tax. While so, the Tahsilar, Usilampatti Taluk, has issued the impugned notice dated 26.12.2025, under Section 6 of the Tamil Nadu Land Encroachment Act, 1905. Challenging the same, the petitioner has filed this writ petition.

2. From the typed set of papers, we find that on 16.12.2025, the petitioner gave his objection / representation seeking for issuance of patta to the subject land, when the notice under Section 7 of the Tamil Nadu Land

Encroachment Act, 1905, was issued. Therefore, we are of the view that when the objection / representation, dated 16.12.2025, for issuance of patta in respect of the subject property is pending, the impugned notice under Section 6 of the Tamil Nadu Land Encroachment Act, 1905, has been issued.

3. In view of the above, the impugned notice dated 26.12.2025, issued by the Tahsildar, Usilampatti Taluk, under Section 6 of the Tamil Nadu Land Encroachment Act, 1905, is hereby quashed and the Tahsildar, Usilampatti Taluk, is directed to consider the petitioner's objection / representation dated 16.12.2025 seeking for issuance of patta on merits and thereafter, proceed further in accordance with law.

4. With the above observation, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
