Today, when the matter is taken up for hearing, learned counsel appearing for the petitioner would submit that it is suffice if the petitioner's application dated 04.11.2023 as well as representation dated 06.11.2023 are directed to be considered and disposed of by the 2nd respondent within a time frame.

The learned Government Advocate appearing for the respondents would submit that the petitioner during his tourist guide duty, used to shout at the officers and in this regard six complaints are lodged against the petitioner and therefore, the respondents are not in a position to renew the petitioner's tourist guide license cum identity card.
