2.Pursuant to the statutory notice issued by this Court on 06.02.2026, the respondents appeared before this Court in person and reported compliance with the order passed by this Court by producing a Demand Draft for a sum of Rs.8,94,806/- in favour of the petitioner, vide cheque No.337678 dated 16.06.2026 drawn on State Bank of India. not in dispute.

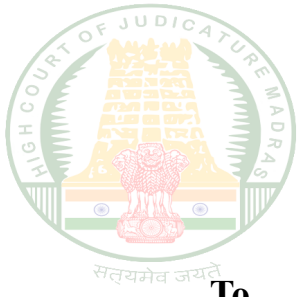
