4.The petitioner herein had alleged that the 7<sup>th</sup> respondent herein had committed encroachment on a public pathway. The said writ petition

was dismissed with strong remarks against the petitioner by this Bench.

We wanted to know if the petitioner's rights have been infringed in any manner. The writ petitioner does not appear to be a neighbor. Therefore, if the 7<sup>th</sup> respondent has committed some illegality, it is for the authority concerned to look into the same and take appropriate action.

5. With the aforesaid observation, the Writ Petition is disposed of.

No costs. Consequently, connected miscellaneous petitions are closed.
