ORDER

Accordingly, the matter was adjourned and posted for further orders today. The learned Additional Advocate General reported that the Commissioner has issued notice for convening the Council Meeting of Madurai Corporation on 10.2.2026.

3.Recording the said submission, the Writ Petition stands disposed of. No costs. Consequently, connected Miscellaneous Petition to implead the 6th respondent as sixth respondent in the main Writ Petition stands closed.
