ORDER

The petitioner is working as BT Assistant (English) in Government Higher Secondary School, Melavalavu, Madurai District. He was placed under suspension by the Joint Director of School Education (Personnel), Chennai, vide proceedings in R.C.No.065968/C3/S1/2023, dated 30.05.2024, on certain allegations. While so, the petitioner has attained the age of superannuation and he was also permitted to retire from service, by a proceedings in R.C.No.065968/C3/S1/2023, dated 24.10.2025. According to the petitioner, though the disciplinary action initiated as against this petitioner on 30.05.2024 is still pending, he was not served with the charge memo so far, even after his representation, dated 28.11.2025. Hence, the petitioner has approached this Court.

2.Today(27.01.2026), when this writ petition is taken up for hearing, the learned Additional Government Pleader appearing
