WEB COPY The petitioner, who apprehends apprehends arrest by the Respondent police in pursuant to the N.B.W. dated 01.08.2019 issued by the Learned Judicial Magistrate No.II, Sattur, Virudhunagar District in P.R.C.No.03/2015 and subsequently the case was Split-up in P.R.C.No.60 of 2025 for the alleged offences u/s. 457,397 & 411 IPC as against the Petitioner, seeks anticipatory bail.

2. The learned counsel for the petitioner submitted that the petitioner was not able to attend for one hearing. Hence, NBW was issued by the trial Court. He further submitted that the petitioner is ready and willing to abide by any conditions which may be imposed by this Court. Hence, he seeks anticipatory bail to the petitioner.

3. The learned Government Advocate(Crl. Side) submitted that it is a case of jumped out bail. Therefore, this Court cannot grant of anticipatory bail to the petitioner.
