Interim injunction earlier granted by us stands vacated.

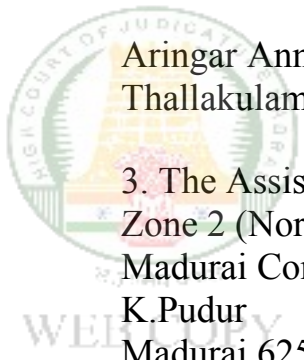
