WEB COPY This Court vide order dated 20.01.2026 directed the petitioner to deposit Rs.5,00,000/- (Rupees five lakhs only) to the credit of Crime No.44 of 2025 before the concerned Court.

2. Today the learned counsel for the petitioner submitted that the petitioner has deposited the said amount on 23.01.2026 for which he produced the receipt before this Court. Accordingly he complied the condition imposed by this Court. The same is recorded.
