2. The learned Government Advocate (Crl.Side) appearing for the second respondent brought to the notice that the petitioner has been implicated in a criminal case in Cr.No.106/2016, which has culminated in filing of charge sheet in C.C.No.271 of 2017 on the file of the learned Judicial Magistrate, Pattukottai, Thanjavur.

3. Considering the abovesaid facts, the petitioner is directed to approach the concerned trial court seeking permission to go abroad. If such
