PRAYER :- For Bail in Crime No.285 of 2025 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner, who was arrested and remanded to judicial custody on 11.12.2025 for the offences punishable under Sections 296(b), 126(2), 109 and 351(3) of BNSS Act 2023, in Crime No.285 of 2025 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner along with other accused persons had waylaid the defacto complainant's son and assaulted him with a billhook, thereby causing injuries on the left hand and left side of the chest. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offences as alleged by the prosecution. He further submitted that the petitioner had already been granted interim bail by this Court on 27.01.2026 and he has co-operated with the investigation. He further submitted that the petitioner is ready and willing to abide by any conditions which may be imposed by this Court.

4. The learned Additional Public Prosecutor submitted that the petitioner has co-operated with the investigation. However, he opposed for grant of bail to the petitioner.

5. The learned counsel for the Intervenor/defacto complainant has vehemently opposed for grant of bail to the petitioner.

6. Considering the facts and circumstances of the case and also the fact that the petitioner had complied with the conditions as imposed by this Court dated 27.01.2026 and the petitioner is ready and willing to deposit some amount to the credit of crime number. Hence, the interim bail already granted by this Court dated 27.01.2026 is made absolute on the following conditions:

(a)the petitioner is directed to deposit a sum of Rs. 25,000/- (Rupees Twenty Five Thousand) to the credit of Crime No.285 of 2025 before the learned Judicial Magistrate Court No.II, Sattur, Viruthunagar, without prejudice to his rights and conditions before the trial Court. Further, the defacto complainant is permitted to withdraw the above said amount on filing proper application before the trial Court.

[b] the petitioner shall report before the respondent police daily at 10.30 a.m., until further orders.

[c] the petitioner shall not tamper with the evidence or witness either during investigation or trial.

[d] the petitioner shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner is released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
