ORDER

Heard Mr.A.Saravanan, learned Counsel for Revision Petitioner and Mr.Vaikkam Karunanithi, learned Government Advocate for Respondent.

This is the second petition seeking relaxation of condition imposed by this Court vide order dated 12.09.2025 in Crl.M.P.(MD)No. 12317 of 2025 in Crl.RC(MD)No.809 of 2025, wherein this Court directed the petitioner to appear before the learned Judicial Magistrate No.II, Kumbakonam, once in a month ie., on the first working day of every English Calendar month at 10.30 a.m., commencing from October 2025, until further orders.
