This Criminal Miscellaneous Petition has been filed to relax the condition No.7(iv) imposed upon Petitioner in Crl.MP(MD)No.5374 of 2025 in Crl.RC(MD)No.522 of 2025 dated 23.04.2025. Condition No. 7(iv) reads as under:-

“7.

(iv) The petitioner shall appear before the trial Court once in a month i.e., on the first working day of every English Calendar month at 10.30., am until further orders.”

2.Heard Mr.M.Kannan, learned counsel for petitioner and Mr.T.Antony Arulraj, learned counsel for respondent.

3. Learned counsel for Revision Petitioner submits that Revision Petitioner has been regularly complying with the conditions imposed by this Court dated 23.04.2025 in Crl.MP(MD)No.5374 of 2025 in Crl.RC(MD)No.522 of 2025. Hence, he prays that Condition No.7(iv) of the order dated 23.04.2025 imposed on the Revision Petitioner may be relaxed. He further prays that Revision Petitioner may be directed to appear before the Trial Court once in every three months.

*(iv) The petitioner shall appear before the trial Court **once in two months** ie., on the first working day of every alternate month ie., commencing from March 2026, until further orders”*
