Having considered the aforesaid submission and the overall facts of the case, this Court permits the petitioner to conduct the candidate introduction meeting for the Thiruvadanai Assembly Constituency at the venue opposite the Thondi Bus Stand, in compliance with all conditions applicable to the grant of such permission.

5. Accordingly, the impugned order passed by the 3rd respondent, dated 19.01.2026 is hereby quashed and this Writ Petition is allowed. No costs.
